M/s Aanya Enterprise Prop Ms. Aishwarya Meshram availed OCC from Indian Bank, Vyapar Vihar, Bilaspur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s Aanya Enterprise Prop Ms. Aishwarya Meshram** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 02.05.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) **M/s Aanya Enterprise Prop ms. Aishwarya Meshram, Ms. Aishwarya Meshram (Proprietor) and Mrs Romi Sahu (Guarantor and Mortgagor)** liable to the Bank to pay the amount due to the tune of **Rs. 20260569.00 (in words Two crore two lac sixty thousand five hundred and sixty nine Only)** as on 01.05.2026. with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 02.05.2026.

As M/s Aanya Enterprise Prop Ms. Aishwarya Meshram failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule

mentioned properties under the Act on 20.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 01.09.2026 is **Rs 21602956.00 (Rupees Two crore sixteen lac two thousand nine hundred and fifty six Only)** with further interest, costs, other charges and expenses thereon from 02.09.2026.

Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 22.10.2026 i.e the e-Auction Date and before the e-auction end time in the portal. The registration and eKYC must be completed well in advance, before auction.
