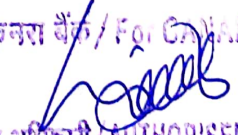

- e) Only after payment of the EMD amount, the intending bidders shall be allowed to participate for the auction bidding process.
- f) The intending bidders should register their names at portal <https://baanknet.com/> and get their User ID and password free of cost. Prospective bidder may avail online training on E- auction from the service provider. Intending bidders shall hold a valid digital signature certificate and e-mail address.
