Mr.Manish Kumar & Mrs.Rishika availed **Home loan & Home Loan repair and renovation** facility from Indian Bank, **Sadar Bazar** Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr.Manish Kumar & Mrs.Rishika** to pay the outstanding dues to the Bank. As **Mr.Manish Kumar & Mrs.Rishika** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **11.11.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the

same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6(2) and 8(6) of the Security Interest (Enforcement) Rules 2002, 30 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.
