Mr. R Mahendran (Borrower) & Mrs. Abhiramhi Mahendran (Co-Borrower/Mortgagor)** having residence at 128/1, Vadakkipalayam Main road, C Goplapuram Pirivu, R Ponnapuram, Pollachi Taluk, Coimbatore 642002, to repay the amount mentioned in the notice being **Rs.2,03,46,480.16 (Rupees Two Crore Three Lakhs Forty-Six Thousand Four Hundred Eighty & Paise Sixteen only)** as on **20.04.2025** and **Rs.1,92,99,686.16 (Rupees One Crore Ninety-Two Lakhs Ninety-Nine Thousand Six Hundred Eighty-Six and Paise Sixteen only)** as on **20.03.2025** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers & Co-borrower/Mortgagor/Guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken possession of the secured assets more fully described in the schedule hereunder on **06.09.2025** under Section 13 (4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs.2,13,64,083.80 (Rupees Two Crore Thirteen Lakhs Sixty-Four Thousand Eighty-Three & Paise Eighty only)** and **Rs.2,07,91,081.77 (Rupees Two Crore Seven Lakhs Ninety-One Thousand Eighty-One and Paise Seventy-Seven only)** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The total dues of both the borrowers as on 07.09.2026 work out to be **Rs.4,51,41,187.00 (Rupees Four Crore Fifty-One Lakhs Forty-One Thousand and One Hundred & Eighty-Seven Only)** after reckoning repayments, if any, after the Bank issuing demand notice.

Terms and Conditions

1. The property(ies) will be sold by e-auction through the service provider <https://baanknet.com> under the supervision of the of the Authorized Officer of the Bank.
2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **14.10.2026 before 10.30 AM**. Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through Net Banking/UPI/NEFT/RTGS/Challan Mode **(in challan mode, after generation of Challan from <https://baanknet.com> which will provide account details, bidder to send NEFT/RTGS)** in bidders EMD Wallet account. Bidders, not depositing the required EMD online and tagging the interested property, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. The Earnest Money Deposited shall not bear any interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.

6. Bidder's Global Wallet should have sufficient balance ($\geq$ EMD amount) at the time of bidding.
7. Online auction sale will start automatically on and at the time as mentioned above. Auction / bidding will initially be for a period of 120 Minutes with auto extension time of 10 minutes each till the sale is concluded.
8. During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount must be as mentioned in the notice to the last higher bid of the bidders. 10 minutes' time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder after the expiry of 10 minutes to the last highest bid, the e-auction shall be closed.

Failure to remit the entire amount of sale price within the stipulated period will result in forfeiture of deposit of 25% of the bid price to the secured creditor and forfeiture of all claims over the property by the purchaser and the property will be resold. In the event of Bidder who is declared as successful bidder failing to pay the
