- f) Auctions would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiplied rates of **Rs. 10,000.00/- (Rupees Ten Thousand Only)** mentioned under the column "Increment Combo" (at least select 1). The bidder who submits the highest bid (above the Reserve price) on closure of 'Online' auction shall be declared as successful bidder. Even if there is only one bidder who has submitted EMD against particular property, the said bidder has to bid at least one increment above the Reserve Price to become successful H-1 bidder.
