M/s Sri Vinayaka Textiles through its Proprietor- Mr.K.Veerappan availed **SOD and SME/MTL** facility from Indian Bank, Komarapalayam Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Sri Vinayaka Textiles failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.12.2018 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) M/s Sri Vinayaka Textiles and others liable to the Bank to pay the amount due to the tune **Rs.51,77,549/- (Rupees Fifty One Lakhs Seventy Seven Thousand Five Hundred and Forty Nine Only)** as on 06.12.2018 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 06.12.2018

As M/s M/s Sri Vinayaka Textiles and others failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 13.02.2019 after complying with all legal formalities.



As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 20.08.2026 is **Rs.1,79,77,175 (Rupees One Crore Seventy Nine Lakhs Seventy Seven Thousand One Hundred and Seventy Five Only)** with further interest, costs, other charges and expenses thereon from 21.08.2026

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.
