Mr. Rameshuddin & Mrs. Dibasha Begum (A/c No:50314428531) with Indian Bank, Kalal Kheriya Agra, Agra Branch facility from Indian Bank, Kalal Kheriya Branch and, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Rameshuddin & Mrs. Dibasha Begum failed** to pay the outstanding dues to the Bank. As **Mr. Rameshuddin & Mrs. Dibasha Begum Account No.:50314428531** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 28.03.2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
