NOTICE OF INTENDED SALE

Mr. P. Vijayaraj (Borrower & Mortgagor) and Mrs. Suriya Prabha (Co-Borrower) have availed Housing Loan from our Yagappa Nagar Branch the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.P. Vijayaraj (Borrower & Mortgagor) and Mrs. Suriya Prabha (Co-Borrower) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 21.05.2021 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower Mr. P. Vijayaraj (Borrower & Mortgagor) and Mrs. Suriya Prabha (Co-Borrower)) liable to the Bank to pay the amount due to the tune of **Rs.19,01,768 /-(Rupees Nineteen lakhs One Thousand Seven Hundred and Sixty Eight only)** as on 21.05.2021 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 21.05.2021.

Mr. P. Vijayaraj (Borrower & Mortgagor) and Mrs. Suriya Prabha (Co-Borrower) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 06.11.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.
